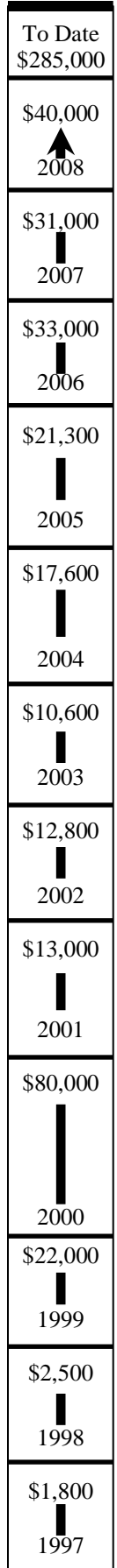

# CAPE COD BAY BASS & BLUEFISH TOURNAMENT



## Rules

1. Unlimited Tackle.
2. All fish weighed are subject to a freshness test.
3. Any attempt to increase the weight of the fish will result in immediate disqualification.
4. All fish are to be weighed at official weigh station at Northside Marina.
5. Fishing hours: 5:00 a.m. July 10th to 4:00 p.m. July 11th.
6. The tournament channel will be 71 VHF.
7. Anglers with fish hooked up, but not boated by 4:00 p.m. Saturday July 11th must notify Committee Boat.
8. Weather committee makes final decision on fishability based on current conditions & NOAA forecasts.
9. Fishing may be stopped, delayed or postponed. Please listen for announcements on CH. 71 during high wind conditions.
10. Rules committee settles all disputes. Protests must be filed in writing no later than 4:00 p.m. Saturday.
11. Weigh station will be open from 4:00 p.m. to 6:00 p.m. Friday and 3:00 p.m. to 5:00 p.m. on Saturday.
12. All boats must be prepared to weigh fish no later than 5:00 p.m. Saturday.
13. Fishing is limited to Cape Cod Bay. The demarcation line runs from Race Point to Marshfield. Check your chart.
14. Fish weighed must be tagged identifying the angler. **No untagged fish will be weighed or entered.** Tags are provided in your Captains bag.
15. **Boat/Team Prizes are the total weight of 3 fish, one of which must be a bluefish.**
16. Both commercial and non-commercial categories have the following prizes: 1st place team/boat; 1st and 2nd place Bass- Kids, Women, Men; 1st and 2nd place Bluefish-Kids, Women and Men.
17. A fish is to be entered in 1 category at weigh-in. Once entered its category can't be changed. Any fish weighed in the 2nd day may replace and supercede a previously entered fish. Fish weights are not announced.
18. Cape Cod Bay Bass & Bluefish Tournament is a recreational tournament abiding by Massachusetts Recreational Saltwater Fishing Rules.
19. Children under 7 are not eligible for prizes.
20. Children's prizes for ages 7 to 16 will consist of trophies.
21. For conservation purposes, a minimum Bass length is 30".

The perfect location boasts access to biking and hiking trails, fresh-water fishing ponds, bayside and ocean beaches and 2,000 acres of forest.

Staff includes a full-time director, camp counselors, volunteers and medical personnel at all times. Activities for campers include whale watching horseback riding, crafts, canoeing, drama program and nature exploration.

Above all, the environment creates lifelong memories, strengthens family relationships and fosters interaction with people who share a common bond.

In consideration of the acceptance of me and my team and crew entry and for other good and valuable consideration received, we hereby remise, release, and forever discharge the Tournament and its respective heirs, executors, administrators, legal representatives, successors and assigns of and from all claims, suits, obligations, liabilities, loses, damages, costs or expenses which our team or our heirs, executors, administrators, legal representatives, successors and assigns may have against the Tournament, arising out of, resulting from, or in any way connected with my participation in the above described tournament. We understand that this release includes any claims based on any negligent act or negligent omission of the Tournament.
